
# Discussion paper dairy indicators



### Dairy LCA - Lift Off


The "IDF Guide to Standard Lifecycle Assessment Methodology for the Dairy Sector", was launched at the World Dairy Summit in Auckland. This methodology was enhanced by the input of the Dairy Working Group, initially by the review of GHG methodologies that they had already undertaken and also through the developmental phases, ensuring that what was published could be implemented in a pragmatic manner. Supporting the document is a dedicated website that provides further background to the LCA approach and features input from individuals along the supply chain, via video and written interviews. Importantly we need to get this methodology used! Please tell us when you are applying it so that we can gauge the levels of implementation.
